

## AMPLEXOR Overview

Region 4 has publicly awarded a competitively solicited cooperative purchasing agreement to AMPLEXOR ([contract #R180701](#)). National IPA participants can use AMPLEXOR's language services to remove communication barriers with any audience, including Deaf and hard-of-hearing (HOH) communities.

Approximately 15 percent (37.5 million) of American adults age 18 and up report some trouble hearing. What does this mean for your organization and how it caters to deaf and HOH individuals?

## What are CART and ASL services?

### CART

- CART is a real-time captioning service that provides instantaneous text for individuals who are deaf, HOH or learning English as a second language
- Speech is converted to text instantly by a person using a stenotype machine (similar to a typewriter) and specialized software
- The real-time text can be converted to numerous platforms, such as
  - Webpages (on any device)
  - Monitors / screens of any size for large or small audiences
  - Streaming platforms (e.g., Zoom, Elluminate, WebEx, Facebook, YouTube, Adobe Connect, etc.)

### ASL

- ASL serves as a visual language for deaf and HOH individuals
- ASL interpreters use hands, body movements and facial expressions to convey information
