The University of California, Office of the President (UC) issued RFP #AM-2019-1-TEMP on February 6, 2019 to select multiple suppliers to support UC locations including campuses, medical centers, national laboratories, the Office of the President its affiliates and California State College (CSU) for temporary staffing services.

The Regents of the University of California partnered with OMNIA Partners to include a national cooperative purchasing opportunity:

*January 1, 2020, The Regents of the University of California (also known as a “Principle Procurement Agency” in material provided by OMNIA Partners) and Contractor partnered with OMNIA Partners to offer the Contract (also known as a “Master Agreement” in material distributed by OMNIA Partners) on a national basis to public agencies who register with OMNIA Partners.*

*Supplier agrees to extend Goods and/or Services to state and local governmental entities, public and private primary, secondary and higher education entities, non-profit entities, and agencies for the public benefit (“Public Agencies”) registered with OMNIA Partners, Public Sector (“Participating Public Agencies”) under the terms of this agreement. Operational issues, fiduciary responsibility, payment issues and liabilities, and disputes involving individual participating public agencies will be addressed, administered, and resolved by each participating public agency.*

The proposals were evaluated by an evaluation committee. Using the evaluation criteria established in the RFP, the committee elected to enter into awards with 22<sup>nd</sup> Century Technologies, Inc., Diskriter, e-Solutions, Expert Staffing West, Howroyd Wright/Apple One, LanceSoft, ManPower Group, Randstad USA, Ronin Staffing, Soft HQ, Inc., Tempostions and Temp Staffing Partners. The University of California (UC), OMNIA Partners, Public Sector and SoftHQ, Inc. successfully negotiated a national cooperative opportunity, and the UC executed the agreement with a contract effective date of January 1, 2020.

Contract includes:

- Candidate services include: Administrative Clerical, Industrial, Engineering, and Finance/Accounting

Term:

Initial four (4) year agreement from January 1, 2020 through December 31, 2024 with the option to renew for two (2) additional one-year periods through December 31, 2026.
